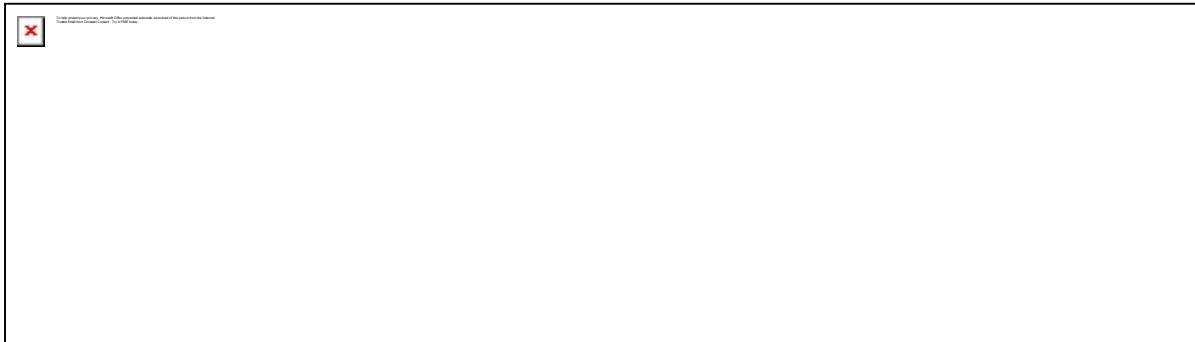
Appointed as the County Executive Officer for the County of Ventura by a unanimous decision of the Board of Supervisors.

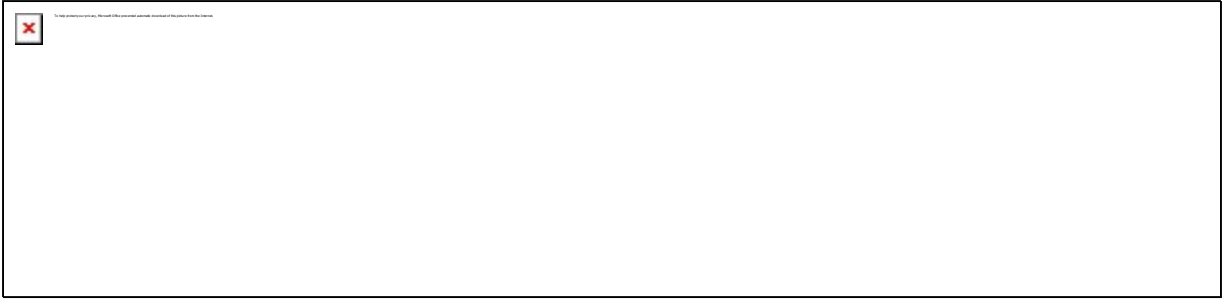

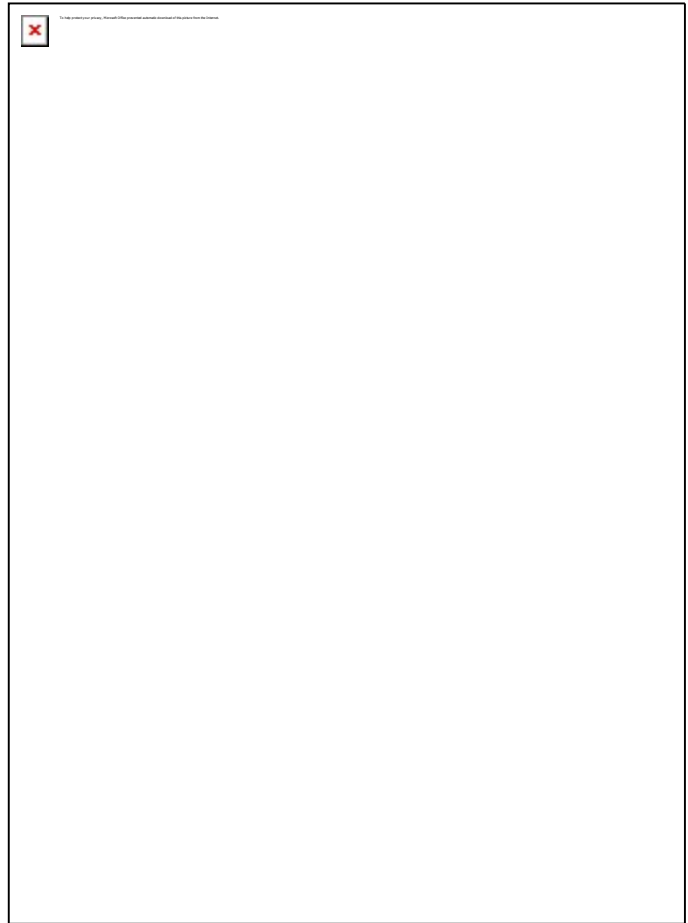

[Children and Youth Behavioral Health Initiative \(CYBHI\) Grant Funding](#), Round 2: Trauma-Informed Programs & Practices: \$100 million to scale evidence-based practices and community-defined evidence practices. CA's DHCS seeks proposals from individuals, organizations, and agencies to scale trauma-informed programs and practices to improve access to critical behavioral health interventions, including those focused on prevention, early intervention, and resiliency/recovery, for children and youth, specifically those from Black, Indigenous, and people of color (BIPOC) and lesbian, gay, bisexual, transgender, queer, and intersex (LGBTQI+) communities. Criminal Justice

[Residential Housing Settings for individuals deemed incompetent to stand trial \(IST\)](#) : CA's Dept. of State Hospitals' Incompetent to Stand Trial Diversion and Community Based Restoration Infrastructure Project provides \$468.8 million in grant funding to California counties to build, acquire, or develop residential housing settings for people who have been deemed incompetent to stand trial. The focus is to provide intensive treatment and wraparound services in a community-based, home-like setting in support of the Felony Mental Health Diversion Program and Community Based Restoration Program. A portion of the CCE budget includes Home and Community-Based Services (HCBS) funding that must be obligated by December 2023 and liquidated by June 2026, as well as State Fiscal Recovery Funds (SFRF) that must be obligated by June 2024 and liquidated by December 2026. Applications funded on a rolling basis.

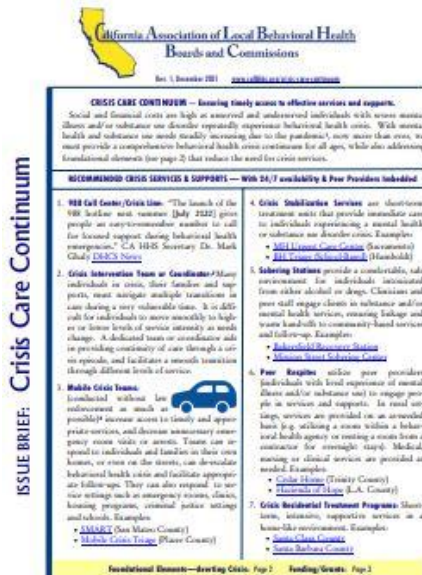
Older Adults
